Why are we developing a scheme?



Current issues

- GM Petunia
- Myrtle rust
- US quarantine
- Pelleted seed

NZPPI is already involved in a number of serious biosecurity issues that are impacting plant producers.



Future risk

- Fusarium
- Xylella
- Sudden Oak Death
- Brown Marmorated Stinkbug
- Ceratocystis fimbriata

Biosecurity is likely to become an even more important issue in the future. We need the systems and tools to enable businesses & nurseries to avoid and manage these issues.

Why are we developing a scheme?



There is an increasing awareness of the potential for nursery plants to spread pests and pathogens throughout New Zealand and into the environments of our customers.

These hazards can spread to: food, wine and forestry production; conservation, revegetation and restoration programmes; landscape, amenity, retail and home garden markets; and other production nurseries.

This Plant Production Biosecurity Scheme is a systematic approach to managing this risk. It helps plant producers identify, control, manage or avoid biosecurity hazards in their nursery and production processes. It will protect the producer, their customers, the environment and the New Zealand economy from the inadvertent introduction and dispersal of a pest or pathogen.




How are we doing it?

We are developing a **biosecurity certification** scheme.

This scheme addresses a range of risks that affect plant production.

The scheme is similar to other schemes in the horticulture sector: E.g. NZGAP, Kiwifruit Plant Certification Standard, Grafted Grapevine Standard, Avocado Hight Health Scheme, Canada's Clean Plants and Australia's BioSecure.


Participation Options

Option: 1 - Registration

Option: 2 - Individual Certification

Option: 3 - Group Certification

Option: 4 - Accreditation / Equivalence





Option: 1 Registration

Producers **register** with the scheme owner.

Minimum registration details will be defined in the scheme rules but will be sufficient to identify and locate the nursery for communication, statistics or in a crisis situation.


Registration details will be held in a scheme register (database) that is accessible to the scheme owner.





Option: 2 Individual Certification

An individual producer holds a certificate for their nursery(s). The producer implements the standard and is externally audited.





Option: 3 Group Certification

A group of producers operate under a single certificate. The group is managed by a lead organisation that holds the certificate and works with the individual producers to achieve the standard.

The lead organisation undertakes internal audits of all group members.

The lead organisation is externally audited & small number of producers in the group are externally audited.







Option: 4 Accreditation / Equivalence



Using a benchmarking process, the scheme owner recognises schemes that meet the PPBS purpose & outcomes.



Producers that are certified to the recognized scheme can seek certification the PPBS.




The Scheme
